Long Island Sound Futures Fund is now open!

Grants ranging from \$50k - \$1.5M will be available for habitat restoration, resilience, water quality improvements, outreach projects, and more! *To get feedback on your project idea, fill out this form* and send to <u>LISFF23@nfwf.org</u> by April 14, 2023.

National Coastal Resilience Fund

RFP is now open! This grant program supports projects that will result in the creation and/or restoration of natural systems to increase the resilience of communities from coastal hazards and improve habitats for fish and wildlife species. Funding is available for: 1) Community Capacity Building and Planning; 2) Site Assessment and Preliminary Design; 3) Final Design and Permitting; and 4) Restoration Implementation.
