# Funding Opportunities

**\*NEW\***

## **Building Resilient Infrastructure and Communities Grant Program**

The Federal Emergency Management Agency (FEMA) has approximately \$1 billion dollars available to support hazard mitigation projects that will reduce the risks of disasters and natural hazards facing communities. This opportunity will promote capacity building and partnerships.

***Applications are due February 29, 2024***

## **Climate Smart Land Stewardship Grant Program**

This grant program strives to integrate climate mitigation, resilience, and adaptation into the stewardship of conserved lands by increasing the number of acres in Connecticut that use climate smart land stewardship practices. There are four opportunities to apply!

***Applications are due quarterly on March 1, May 1, August 1, and November 1, 2024***

## **Brownfield Remediation and Development Opportunities**

There are four subprograms offered by the Office of Brownfield Remediation and Development that seek to help support projects on brownfields. There will be four webinars throughout January and February to provide more information on these funding opportunities (see below for webinar details).

***Applications for all opportunities are due March 1, 2024***

## **Connecticut Recreational Trails Funding**

This grant opportunity can be used for projects focused on improving trails throughout the state through planning and construction, maintaining current trails, increasing accessibility, equipment purchase, land acquisition, and safety programs.

***Applications are due March 11, 2024***

## **CT DEEP Urban Forest Equity Grant Program**

From tree plantings, to invasive species management, to urban food forests and so much more, this grant program will support urban and community forest projects that increase equitable access to trees and the benefits they provide in marginalized communities.

***Applications are due April 17, 2024***

## **Environmental and Climate Justice Community Change Grants Program**

Over \$2 billion dollars is available through the Inflation Reduction Act funds for projects that reduce pollution, increase community climate resilience, and build community capacity to address environmental and climate justice challenges.

Technical assistance is also available to assist eligible applicants to apply for and use EPA grant funding

***Applications are accepted on a rolling basis until November 21, 2024***

### **National Estuary Program Watershed Grants**

The nationally competitive NEP Watersheds Grant Program is now accepting letters of interest. Check out the link to learn more about the project priorities and how to apply.

### **Five Star and Urban Waters Restoration Grant Program**

The Five Star Urban Waters Restoration Program is an opportunity focused on developing community capacity by funding projects focused on improving water quality, watersheds, and the species and habitats in these spaces.

***Full proposals are due on January 31, 2024***

### **Long Island Sound Stewardship Fund**

The Long Island Sound Stewardship Fund (LISSF) is a competitive grant program seeking proposals to restore and protect the health and living resources of Long Island Sound. The most competitive proposals will incorporate multiple values including sustainability, resilience, and diversity, equity and inclusion.

***Submissions are due February 1, 2024***

### **Greater New Haven Green Fund**

The Green Fund seeks innovative proposals from committed organizations and individuals in New Haven, East Haven, Hamden, and Woodbridge for activities that advance their mission which is to promote environmental quality, public health and equity in the community by providing grants and other incentives that contribute to a more environmentally sustainable future and reduce pollution.

***Applications are due February 2, 2024***

### **FY2024 Clean Water Act Section 319 Nonpoint Source Management Grants**

CTDEEP is now accepting proposals for the Clean Water Section 319 Nonpoint Source Grant Program. Priorities include environmental justice and environmental equity, climate resiliency, watershed-based plan implementation projects, implementation projects not associated with watershed-based plans, and watershed-based development plans.

***Proposals are due February 8, 2024***
