Year in Review: Long Island Sound 2023

Interested in learning about what we've been up to? 2023 was a busy year for the Long Island Sound Study! \$12 million was awarded to 39 projects through Long Island Sound Futures Fund Grants and we've witnessed the incredible ways these funds have been used. During the last reporting period it was noted that 232,932 people engaged in Long Island Sound education initiatives, 1,143,882 gallons of stormwater was treated through green infrastructure projects, and 1,409 volunteers participated in restoration and stewardship opportunities. The Connecticut Land Conservation Council's Transaction Assistance Grant (TAG) Program seeks to accelerate the pace of land conservation by providing financial assistance to land trusts for transaction-related project costs. TAG responds to immediate conservation needs and is designed to get funding on the ground efficiently and effectively. Applications for TAG grants are accepted monthly, with applications due on the last day of a given month as long as funds are available.

Application Deadline: July 31, 2024 (monthly)

[Reconnecting Communities Pilot \(RCP\) Discretionary Grant Program](#)

Available through the Office of the Secretary of Transportation and US DOT, the RCP makes awards on a competitive basis for projects that reconnect communities by removing, retrofitting, or mitigating highways or other transportation facilities that create barriers to community connectivity, including to mobility, access, or economic development.
