### [NFWF Long Island Sound Futures Fund](#)

The National Fish & Wildlife Foundation is seeking proposals to restore the health and living resources of Long Island Sound. This grant program supports efforts to test innovative approaches to conservation, deliver transformative projects, and support people and communities who value the sound and take a direct role in its future.

**Applications Due: May 29, 2025**

### [Outdoor Recreation Legacy Partnership Program](#)

The ORLP is a nationally competitive, dollar-for-dollar matching grant program. It was created to aid disadvantaged, urban communities that lack access to close-by outdoor recreation. Funds can be used for the acquisition and/or development of, or substantial renovation of, public parks and other outdoor recreation spaces.

**Applications Due: June 1, 2025**

### [Community Investment Fund 2030 - Round 7](#)

To foster economic development in historically underserved communities across Connecticut, the CIF will provide a total of up to \$875 million to eligible municipalities as well as not-for-profit organizations and community development corporations that operate within them.
