

This program established by the Bipartisan Infrastructure Law provides funding for projects that would meaningfully improve or restore passage for anadromous fish including culvert and weir replacement, removal, or repair.

Connecticut Town Profiles Data Sets

The Connecticut Town Profiles is a project of [CTData Collaborative](#) in partnership with [AdvanceCT](#) (formerly the Connecticut Economic Resource Center). The Connecticut Town Profiles are two-page reports of demographic and economic information for Connecticut's municipalities, regions, and the state as a whole. They contain information about population, major employers, education, fiscal information, labor force, housing and quality of life.

Culverts & Climate Resilience Fact Sheet

This fact sheet produced by the Connecticut Institute for Resilience and Climate Adaptation (CIRCA) reviews how culverts are defined in Connecticut, explains their connection to climate resilience, provides examples of how Connecticut towns are addressing needs for upgraded culverts, and highlights related resources.

Drainage Network Interactive Map

This interactive map published by the CTDOT in March 2025 allows users to view data layers that make up the state-owned and maintained drainage network across Connecticut. Culvert locations are included, as well as their water source, material components, type of conveyance, diameter, length, last inspection date, and maintenance information.
